REPORT OF HEAD OF CENTRAL SERVICES

BUDGET MONITORING APRIL TO JUNE 2011

1.0 PURPOSE OF THE REPORT

1.1 To provide information on actual expenditure and income incurred on this Committee's services compared to the latest approved budget for the period 1 April 2011 to 30 June 2011.

2.0 **RECOMMENDATION**

2.1 It is recommended that the financial position on each of this Committee's services to 30 June 2011 be noted.

3.0 **KEY ISSUES**

3.1 As part of the Council's budget monitoring procedures all budget holders are asked on a quarterly basis to provide details of service and financial performance. Copies of the budget holders' returns are available for further information.

Overall Position

3.2 A summary of income and expenditure for all Council services is attached at Appendix A and detailed below. This information has previously been circulated to Members as part of the August Members' Newsletter.

Key Service Areas

- 3.3 The latest Key Service Areas report is attached at Appendix B with the Policy, Finance and Administration service areas highlighted. This report is presented to the Management Team on a monthly basis and highlights the high-risk budgets that were identified as part of the Council's budget protocols. These budgets are reviewed with budget holders monthly. Those budgets which are more complex in nature are supported by more detailed analysis of the service usage that drives the costs.
- 3.4 The report shows that, for those services for which this Committee is responsible, the level of income for both land charges and investment is very much as expected.

- 3.5 The overall position on the Key Service Areas shows a deficit of just over £51k mainly due to the reduction in the level of income in relation to car parks and planning and building control application fees, however, this is offset to some degree due to the predicted increase in benefits subsidy. These budgets will be carefully reviewed as the year progresses.
- 3.6 There are also a number of other budget variances identified on the budget action list, including those relating to Key Service Areas above, which are considered by the Council's Strategic Management Team on a monthly basis. As such the overall current predicted position, when taking into account all known variances, shows a net overspend of just over £92k.
- 3.7 A summary for all of this Committee's services is attached at Appendix C.
- 3.8 A summary of the income and expenditure for this Committee's services compared to the approved budget at June 2011 is as follows:

3.9 The above figures for general expenses show an overspend of £53,197 the reasons for which are explained in paragraph 3.10 below.

Budget Variance Exception Reporting +/- £10k

3.10 As part of the budget monitoring process variances are being promptly and proactively managed facilitating more detailed reporting. Details of the potential 'full year' effect of the more significant variations +/-£10k with regard to this Committee's services are set out below:

Underspends

(a) <u>Elections - £55,985</u>

Borough/Parish Council election costs to be transferred from the referendum account.

(b) Corporate & Democratic Core - £37,828

No significant variations at this stage in respect of budgets under direct control, however, support costs, due to profiling are lower than the quarterly budget (£32k).

(c) Council Tax Collection - £30,082

Increase in income from legal costs (although there will not be an increase in the predicted year end position), together with a number of small variations in respect of supplies, which will be committed later in the year.

Overspends

(a) Misc. Financing Items -£54,938

Savings target from the restructuring process where savings have been achieved was transferred to services in August.

Support Services £130,489 Overspend

Budget variances in respect of Support Services are attributable to the differences in the profiling of expenditure and income (i.e. recharges to services).

4.0 POLICY AND CORPORATE IMPLICATIONS

4.1 Policy and corporate implications were addressed in setting the current year's budget. There are no further policy and corporate implications arising from this report.
