Reasons

To provide a piece of equipment for the Country Park that will have the positive benefits of :

- Increasing the recreational activities available at the park
- Fit with the Councils Health and Fitness Agenda
- Suitable for play and exercise activity for a wide range of ages i.e. 5yrs -65+yrs.
- A contemporary modern robust piece of play equipment designed to stimulate interaction and game playing between both same age and differing aged children and adults.
- Expected to provide fun, improve fitness, stimulate healthy outdoor activity and be of social and community benefit
- Further supports the Green Flag award application expected to be submitted during 2011.

Options

- There are currently no comparable pieces of similar equipment available
- There are a couple of alternative supplier's attempts at copies but they are different, not of the same quality and remain unproven.

The proposed unit is essentially unique, can only be purchased outright

Benefits expected

The unit offers play activity and exercise to a wide range of ages and fits with the healthy lifestyle, creative play and outdoor exercise agendas/ stealth fitness. It will also further enhance the range of activities within the Country Park and support the intended application for a Green Flag award to be submitted in 2011

Risks

There are very few risks with this project, the supply and installation will be through 'Playdale' a recognized leading UK play equipment manufacturer. They are keen to install the unit as soon as possible. The correct installation and functioning of the unit is covered by guarantee. There are no external time constraints.

(i) **Funding Source** – this project is to have its capital purchase and installation costs covered by developer '106' contribution funds. This is essentially relevant external developer 106 contribution funding provided as part of the recent private domestic housing development in Melton Mowbray on Doctors Lane

Timescales

Playdale are keen to supply & install at the earliest opportunity. Once approval is given this should be within 6-10 weeks from approval.

Investment appraisal

This is a new contemporary additional play activity for Melton Country Park. The unit is expected to bring positive benefit in terms of tangible considerations such as

- Improved Town outskirt Facilities
- Increased play and recreational value for Melton Country Park
- Improved overall range of leisure pursuits
- Increased fun activity and healthy promotion

Intangible benefits include:

- Reduced antisocial behavior with increased welcome alternative activities
- Potential for entry to I-Play leagues
- The remote reprogramming function allows for live updates and game changes maintaining its play value and contemporaneous nature.

The cost benefit would indicate considerable benefit achieved for a reasonable investment.

Evaluation

In terms of the Mckinsey 7S evaluation framework this project has implications for :

Scope

The installation is basically an outdoor piece of play equipment that is operated as an outdoor electronic games unit designed to encourage team play as well as individual fitness regimes and is expected to attract a wide ranging age group of participants. The scope includes exercise, play, social inclusion and healthy activity/play and stealth fitness

The unit is modern and attractive to many age groups. It meets the healthy lifestyle agenda and is expected to further increase the diverse uses for the Country park. The unit will be funded form 106 monies with a revenue implication for MBC of £200 per year .This will enable live updates , new games and a number of full remote repairs and fixes
