REPORT OF THE MONITORING OFFICER

REVIEW OF THE COUNCIL'S CONSTITUTION 2010/11

1.0 PURPOSE OF THE REPORT

- 1.1 The Council is requested to consider a list of proposed amendments to the Constitution that were considered by the Constitution Review Task Group on 29 March 2011 and the Overview, Scrutiny and Audit Committee on 11 April 2011. The detail and associated appendices are enclosed at Appendix A.
- 1.2 The Council is requested to note that there have been two items approved for inclusion in the Constitution at Council Meetings this Civic Year and they are as follows:-
 - the Petitions Scheme including E-Petitions
 - the Reduction in Site Visit Allowance for Members to £25 to allow a £5 contribution to a buffet between the Site Visit and the Committee meeting
- 1.3 The item relating to the Calendar of Meetings is to be disregarded in the appendices as it was required to be approved at the Annual Meeting of the Council on 19 May 2011.

2.0 RECOMMENDATIONS

- 2.1 To approve the Overview, Scrutiny and Audit Committee's recommendations set out at Appendix A.
- 2.2 The Constitution be amended in accordance with 2.1.
- 2.3 To note that there have been two items approved for inclusion in the Constitution at Council Meetings this Civic Year and they are as follows:-
 - Petitions Scheme including E-Petitions
 - Reduction in Site Visit Allowance for Members to £25 to allow a £5 contribution to a buffet between the Site Visit and the Committee meeting
- 2.4 To note that the revised Constitution will be made available electronically to Members and Officers to meet the Council's commitment to the paperlight project.
- 2.5 The item relating to the Calendar of Meetings be disregarded due to having been resolved at the Annual Meeting of the Council.

3.0 **KEY ISSUES**

- 3.1 Since the last review of the Constitution in 2009/10, items have been collated for the 2010/11 review and these were considered by the Constitution Review Task Group on 29 March 2011 and then referred to the Overview, Scrutiny and Audit Committee on 11 April 2011.
- 3.2 The Overview, Scrutiny and Audit Committee considered an additional item relating to a revised Exempt Information Provision for 7(c) as well as revised versions of the Calendar of Meetings and Part 7.
- 3.3 The Committee requested that schemes for :
 - Substitution at Meetings
 - Use of Private Vehicles by Members in connection with Council matters

be produced and presented to a future meeting of the Constitution Review Task Group.

- 3.4 There have been two items approved for inclusion in the Constitution at Council Meetings this Civic Year and they are as follows:-
 - Petitions Scheme including E-Petitions
 - Reduction in Site Visit Allowance for Members to £25 to allow a £5 contribution to a buffet between the Site Visit and the Committee meeting
- 3.6 It is intended that an updated electronic version of the Constitution will be made available to Members and Officers in the new Civic Year 2011/12.

4.1 The Constitution is subject to annual review and due to it being a living document there may be requirements for change, which become apparent throughout the year. These may be collated for the next Constitution Review Task Group or, if urgent, may be considered at the next Full Council Meeting.

The proposed revisions to the Scheme of Delegations to Officers provide that the Monitoring Officer has delegated authority to authorise amendments to the Constitution following legislative or other statutory changes and minor procedural and operational changes. Such changes to be reported to the Overview, Scrutiny & Audit Committee.
