Melton Village Facilities Audit 2011

APPENDIX I

This audit considers the range of local community facilities (primary school, post office, general store, general medical practice, pharmacy, community and leisure facilities, employment opportunities) and availability of public transport in Melton's villages.

The audit was completed in December 2011 following an assessment of the facilities and public transport. Comments on the accuracy of the audit have also been invited from parish council's.

NOTES:

Where a village has more than one example of a community and leisure facility (for example, two public houses, or a public house and community hall) it will meet 'community and leisure facilities' in the above list, effectively scoring 1 facility and service towards the threshold.

An assessment of quality is also made to determine whether the community has reasonable access to a service or facility i.e. a part time post office operating from a dwelling may not provide adequate access if the range of services and opening times are restricted.

The outcome of the audit is documented in the *village facilites table Dec 2011* and the responses received are documented in the *village facilities audit Dec 2011: consultation responses received* table.

MELTON LOCAL DEVELOPMENT FRAMEWORK CORE STRATEGY – VILLAGE SERVICES AND FACILITIES AUDIT
