<b>Sponsorship</b>	Please specify any payment or provision of any other financial benefit made or provided to you in respect of any expenses incurred in carrying out your duties as a Member, or towards election expenses. This should include any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
