The Chairman opened the meeting by welcoming everyone and introduced the attending Councillors and Officers.

## **GS1.3** CONSIDERATION OF MEMBER COMPLAINT GOV 20

The Monitoring Officer submitted a report in consideration of Complaint GOV 20 (copies of which had previously been circulated to Members) and read out the

main points of the report which enabled the Committee to consider the complaint received regarding the conduct of a Council Member and to consider what action should be taken. The Monitoring Officer stated that she had sought the advice of one of the Council's Independent Persons and this was attached as Appendix F and attention was drawn to this being a revised version which had been issued to Members.

The Sub Committee considered the complaint together with the other appendices including the Independent Person's opinion at Appendix F in order to decide whether:-

- No action be taken
- The complaint be referred for other action such as training, support, mediation
- The complaint be referred for Investigation

The 7 Nolan principles contained in the Code of Conduct (Appendix C) where each considered by the Sub Committee as follows:-

Principle 1- Selflessness All agreed not breached

Principle 2 – Integrity All agreed not breached

Principle 3 – Objectivity All agreed not breached

Principle 4 – Accountability Agreed not breached

Principle 5 – Openness Agreed not breached

Principle 6 – Honesty Agreed not breached

Principle 7 – Leadership Agreed not breached

The Chair reiterated the recommendations available to the Sub Committee as being No action or Other action such as training, support mediation or Refer for investigation.

The Chair proposed that no action be taken and this was seconded by Councillor Botterill and on being put to the vote, was unanimously carried.
