CHRISTINE LARSON	ANON-BHRP- 4HUU-J	I support MBC identifying the green areas of special landscape or environmental interest. The Vale of Belvoir villages are uniquely situated between both the Wolds escarpment and the Grantham Canal. This area is both ecologically important for its great crested newt population as well as for the landscape and heritage. Whilst the southern slopes of the escarpment are clay, sloping and rated as less than perfect land for arable, these slopes are ideal for beef and dairy grazing and the area is a reflection of how a landscape can tell the history of it's food production - cheese and pork pies (pigs being fed whey). These slopes should not be built on or spoilt, but protected for their heritage, farming and flood alleviation benefits. Within the parish we have 31 listed buildings and a history going back to before the Romans. To ensure the protection of this landscape, heritage and ecology, all development must be small and organic, in keeping with the 'midlands village style and architecture'. The Vale should be part of the Borough's Tourism strategy - offering some of the best walks and views in the country as well as excellent horse riding and cycling, and possibly boating if the canal is opened up. The wolds escarpment and Vale should be protected from wind turbine development. Last year on Appeal the Inspector rejected an application to erect a 79M turbine on top of the wolds ridge - supported by MBC. The Inspector wrote "In the absence of a specific development plan policy relating to renewable energy it is unsurprising that the proposal would conflict with LP policy C2. Whilst conflict with the development plan and harm to the setting of a listed building are capable of being outweighed by the benefits of a proposal, given the extent of the harm that I have identified to the character and appearance of the area and to the setting of the listed windmill, the benefits of the appeal scheme are insufficient to outweigh the totality of the harm.
