## HOUSING REVENUE ACCOUNT (HRA) - REVIEW OF FEES AND CHARGES 2011/12

## 1.0 PURPOSE OF REPORT

- 1.1 To provide information on the various fees and charges that are made by this committee for the HRA.
- 1.2 To recommend changes to these charges to operate from 1 April 2011, other than Council dwelling rents which will be subject to a separate report to be presented to this committee in January 2011.

### 2.0 **RECOMMENDATIONS**

2.1 That the committee determines the level of charges for 2011/12 for each of the services set out in the attached table as per Appendix A.

#### 3.0 **KEY ISSUES**

3.1 This report deals with fees and charges for the Housing Revenue Account.

The proposed charges for services within the HRA for the financial year 2011/12 are set out below and in Appendix A.

## 3.2 **Accommodation Charges**

3.2.1 Charges are made to tenants of sheltered schemes for the provision of ancillary services in addition to the rent that is charged for the dwelling. The recommended charges for 2011/12 are set to recover the full costs of providing the ancillary services. Such payments are eligible in full in determining a tenant's entitlement to housing benefit.

5.1 The increased charges would provide additional resources of £10,065 in total to the HRA. (£3,736 for Garage income). This will be fed into the estimates being set for 2011/12 which will be presented to members with the rent setting recommendations in January 2011.

#### 6.0 **LEGAL IMPLICATIONS/POWERS**

6.1 Local Authorities have certain limited freedoms to charge for discretionary services under the Local Government Act 2003. Where appropriate any other relevant legislation is noted within the Appendix A to this report.

#### 7.0 **COMMUNITY SAFETY**

# 8.0 **EQUALITIES**

8.1 The concession policy agreed by the Council has implications on equalities and is expected to be more likely to benefit rather than to adversely affect any minority group, as it is aimed at ensuring fair access to all residents linked to their ability to pay.
