DECC Local Authority Competition 2012-13

Thank you for your application to the DECC Local Authority Competition. All of the bids for funds have now been considered by an assessment panel on the basis of the criteria set out in the competition information pack. There was a great deal of interest in this competition and the amount of support requested far outstripped that available. As such, we have had to make some difficult decisions, only supporting those bids that very strongly met the published criteria.

We are writing to inform you of the outcome of assessment. In summary the panel felt that all elements of your application strongly met the criteria for support. We propose to allocate funding as follows:

- For Fuel Poverty £2,373,000 of capital funding and £119,600 of programme funding, totalling £2,492,600.
- For Green Deal Pioneer Places £269,474 of capital funding and £330,526 of programme funding. Totalling £600,000. We have revisited bids to check Capital/Programme splits and you may find that the figures set out in your bid are different to this

We recognise that delivery timetables are tight and we are making every effort to keep administration as quick and effective as possible. All offers of funding are subject to agreement of a Memorandum of Understanding (MOU), setting out guidance for use of grant. We will shortly be sending you a draft of the MOU. If you wish to accept the offer you should submit your formal acceptance to the mailbox la.funds@decc.gsi.gov.uk, along with a signed copy of the MOU, by Friday 11th January. If you will not be able to meet this deadline please let us know as soon as possible. You are strongly advised not to incur any expense or enter into any binding arrangements until such time as this is signed by both parties.
