REPORT OF THE HEAD OF COMMUNITIES & NEIGHBOURHOODS

ARMED FORCES COMMUNITY COVENANT

1.0 PURPOSE OF REPORT

1.1 To seek members approval to move forward towards the sign up to the Community Covenant Pledge.

2.0 **RECOMMENDATIONS**

- 2.1 Members support further work to progress actions which will support the delivery of the principles contained within the Community Covenant Pledge.
- 2.2 Members approve the establishment of a task and finish group in line with the terms of reference identified in para 3.6 of this report.
- 2.3 Members instruct officers to bring a report back to the 20 March 2013 Community & Social Affairs Committee with progress and view to sign the Community Covenant Pledge.

3.0 KEY ISSUES

3.1 Background

- 3.2 A Community Covenant is a voluntary statement of mutual support between a civilian community and its local Armed Forces Community. It is intended to complement the Armed Forces Covenant, which outlines the moral obligation between the Nation, the Government and the Armed Forces, at the local level.
- 3.3 The aim of the Community Covenant is to encourage local communities to support the Service community in the area and nurture understanding and awareness amongst the public of issues affecting the Armed Forces community.
- 3.4 Many people have become involved in supporting the Service community, through Service charities or more recently by participating in Armed Forces Day. They have shown their support in a variety of ways including fundraising, military celebrations, open days and family fun days. The Community Covenant scheme aims to build upon this support.
- 3.5 Melton has the Army Defence Animal Centre as well as a few surrounding service bases with a number of families and personnel likely to be living in the Borough. In addition, it would be a good opportunity to sign up in order to build partnerships with the Armed Forces, so that come 2015 and the celebration of 70 years since the end of World War 2, we can promote and celebrate the good work Melton Borough Council and other partners have done as well as commemorating those who have served their Queen and Country.
- 3.6 To ensure that we start to progress some of the principles set out in the pledge, members are asked to consider the establishment of a Task & Finish group with the terms of reference as follows: 'To identify and deliver key actions that deliver

the principles set out in the Armed Forces Community Covenant', with specific actions to include:

- Identify the individuals/families living in Melton Borough
- Engage with the Armed Forces in Melton gain a contact
- Understand the levels of engagement at County and with other Districts
- The Melton Community Partnership to have an Armed Forces representative on board
- To conduct some workshops (armed forces, businesses, health, education, voluntary sector, district and county)
- Form an action plan from the workshops to be approved and implemented
- The Task Group will report back to this Committee in March with a progress and update.

Councillor Simon Lumley has advised officers that he would wish to activity participate in the task group and its programme of work.

4.0 POLICY AND CORPORATE IMPLICATIONS

4.1 The Melton community covenant statement relates to the Melton Corporate Plan. Some of the clear priorities that relate to this strategy are:
