REPORT OF THE HEAD OF COMMUNITIES & NEIGHBOURHOODS

MELTONS DEMENTIA REPORT

1.0 PURPOSE OF REPORT

1.1 To inform members of the actions that have been delivered and future progress to be untaken, following partnership with the Alzheimer's Society in 2013 and Melton Borough Council signing up to the Leicestershire Dementia Action Alliance in January 2014.

2.0 RECOMMENDATIONS

2.1 Members to note past actions and approve the work to progress actions identified in Appendix A which will support the delivery of the principles contained in the National Dementia Action Alliance.

3.0 KEY ISSUES

3.1 Background

- 3.1.1 In Leicestershire and Rutland there are 126,200 people over the age of 65, of which 9,257 live in Melton. By 2020 Melton's population of individuals 65 and over is estimated to reach 12,200 by 2030 it is estimated to be 16,000. In Leicestershire it was estimated that 8,115 people were diagnosed with dementia in 2011, by 2025 it is predicted that will rise to 12,729 people diagnosed.
- 3.1.2 Melton Borough Council has been in partnership with the Alzheimer's Society since April 2013. Together we have delivered two dementia events, a number of dementia friend information sessions, raised awareness and supported carers. There is much more work to be taken forward with an increasing number of individuals living with dementia or taking care of someone who has been diagnoses.
- 3.1.3 In January 2014 Melton Borough Council sign up to the National Dementia Declaration and therefore became a part of the Leicestershire Dementia Action Alliance. This is made up of various organisations from across Leicestershire all with the same aim, to improve the lives of people living with dementia and their carers. The Leicestershire DAA approach is to have a strong coordinated approach is address the dementia challenge in Leicestershire and improve the lives of the individual living with dementia and their carer/s.
- 3.1.4 One of the aims of the local alliance is to identify 2 areas within the region who will aim to work towards becoming dementia friendly communities. Melton has not been one of those areas which has been selected however it does not mean that we cannot look to register. In the action plan appendix A, Melton Borough Council is looking to build a partnership of various different key organisations and agencies (carers, Age UK, Alzheimer's Society, GP, CCG, individual living with dementia) in order to have a strong group to take forward the criteria that is set out in the Dementia Friendly Communities guidance.

3.1.5 The action plan informed members of the previous work that has taken place and some of the actions that are will be happening. A short report has also been produced providing a little more details on what has been achieved and the future recommendations Melton Borough Council wishes to reach, appendix B.
