# REPORT OF THE HEAD OF CENTRAL SERVICES

## RESURFACING OF CAR PARK SERVING MELTON COUNTRY PARK VISITORS CENTRE AND CAFÉ

#### 1.0 **PURPOSE OF REPORT**

1.1 To seek members approval to re-surface and improve the car park serving Melton Country Parks Visitors centre and café and the Business Case attached at Appendix A

### 2.0 **RECOMMENDATION**

2.1 Members approve the re-surfacing of the car park serving Melton Country Parks Visitors centre and cafe in accordance with the Business Case attached at Appendix A and the works be carried out following all the necessary approvals.

### 3.0 KEY ISSUES

3.1 Members approved a project mandate for the car park works together with replacement of a septic tank in 2015/16 in the sum of £26,775. The septic tank was replaced in 15/16 as an urgent Health and safety item using part of the budget and part repairs and maintenance. Officers are now seeking approval to spend the remainder budget of £23k to replace the surface of the car park and also provide four tarmac disabled parking bays with appropriate access.

## 4.0 **POLICY AND CORPORATE IMPLICATIONS**

4.1 The renewal and replacement programme for the car park is supported by a condition survey and capital programme. The access improvements were identified as part of a property portfolio wide access survey on all General Fund Council properties.

#### 5.0 **FINANCIAL AND OTHER RESOURCE IMPLICATIONS**

5.1 The residual funds for the project of £23k have been allocated for the Capital Programme in 2016/17.The works will be supervised using internal resources.
