THE SCOUTS- HOLWELL PASTURES PROJECT- COMMUNITY FACILITY GRANT

1.0 **PURPOSE OF REPORT**

1.1 To seek members approval to award a Community facility Grant of £25,000 to the Melton Mowbray and District Scouts, to support their Holwell Pastures Project.

2.0 **RECOMMENDATIONS**

It is recommended that:

2.1 Members approve the Business Case attached as Appendix C outlining a Community facility Grant of £25,000 to the Melton Mowbray and District Scouts in support of their Holwell pastures Project and include it into the capital programme for 2016/17.

3.0 KEY ISSUES

- 3.1 Melton Mowbray & District Scout Council is the umbrella organisation for Scouting in Melton and has been active for over 80years. Their overall objective is to help young people enjoy new adventures, interact with others, gain confidence and have the opportunity to reach their full potential.
- 3.2. The funding being sought is to significantly improve the camp site facilities at Holwell pastures and make it more attractive location not only for Scouts but for a much wider range of community purposes.
- 3.3 Holwell pastures has two fields, a collection of old buildings along one side and a good size car parking area. Planning Permission has been granted for the significant work, which includes demolishing the old buildings and replace them with a 32m x 12m single storey wooden building on a brick base.
- 3.4 Full details of the work proposed and the business case developed by the group in support of this project are attached as Appendices A and B respectively. Appendix B is the Council's Community Faculties (Large Grants) form that was completed in the first instance, the costs indicated in the form have changed and Appendix A are more up to date.

4.0 **POLICY AND CORPORATE IMPLICATIONS**

 - Helping to provide homes and environments that meet local needs.
 - Promoting equality of opportunity and encouraging strong, healthy and resilient neighbourhoods.
