# REPORT OF HEAD OF COMMUNITIES & NEIGHBOURHOODS MELTON BOROUGH COMMUNITY LOTTERY

#### 1.0 PURPOSE OF REPORT

1.1. To gain agreement from members to finalise the criteria that 'Good Causes' need to comply with in order to be accepted as a beneficiary.

#### 3.0 KEY ISSUES

#### **Background**

- 3.1 The Council's Policy, Finance & Administration Committee has agreed to the development and implementation of a local lottery for the Borough of Melton that will benefit good causes within the Borough of Melton.
- 3.2 In order for a local community organisation to be accepted as a beneficiary from the lottery they must comply with a set of criteria that also complies with the rules of the Gambling Commission. The Policy, Finance & Administration Committee has delegated the decision to agree the criteria for the lottery to this committee in recognition of this committee's responsibility in respect of community development.
- 3.3 The lottery will be managed and operated via a dedicated website. Gatherwell Ltd is currently building a website which will be used as part of the marketing strategy. In addition to the website marketing materials, banners and stands are being produced to promote the lottery.
- 3.4 As part of the promotion and marketing of the lottery clear guidance will be given to good causes to ensure that they can be clear if they can apply prior to completing the on line registration process.

#### 4.0 POLICY AND CORPORATE IMPLICATIONS

4.1 The lottery will be added as a new service of the Policy, Finance & Administration Committee.

#### 5.0 FINANCIAL AND OTHER RESOURCE IMPLICATIONS

5.1 A budget has been agreed to support the set up and management of the lottery which has been agreed by the Policy, Finance and Administration Committee.
