REPORT OF HEAD OF COMMUNITIES & NEIGHBOURHOODS

APPROVAL OF BUSINESS CASE- PLAY EQUIPMENT- INCREASE CAPITAL EXPENDITURE

1.0 PURPOSE OF REPORT

1.1 To seek members approval for the revised Play Equipment Business Case, and increase the authorised spending by a further £8k from monies currently set aside for play area equipment renewal within the capital programme.

2.0 **RECOMMENDATIONS**

It is recommended that:

2.1 Members to approve the revised Play Equipment Business Case attached as Appendix A, which shows an increased spend of £8k of capital expenditure for the purchase of new play equipment for the Scalford Brook Play Area; and recommend to the Policy Finance and Administration Committee that funding be allocated from the special expenses reserve.

3.0 **KEY ISSUES**

3.1 Play Equipment

Members of the Policy and Financial Affairs committee gave approval in July earlier this year to renew play equipment at both Scalford Brook and West Green play areas. Included with the Scalford Brook scheme was a special piece of equalities compliant equipment a 'swirl unit 'particularly suitable for those that might be wheelchair bound

This request for the approval to release additional funds relates in the main to the cost of additional safety surfacing required to ensure satisfactory compliance with current Health and Safety regulations for the installations of the new equipment

- 3.2. Members may be aware that safety surfacing can be all but the costliest element of equipment renewal depending upon the type extent and depth of the safety surface required.
- 3.3 The play area renewal and replacement programme approved in 2014 had identified £68k of capital expenditure for equipment renewals or replacement that might be needed in 2016/17 However when the sites identified for renewal within that programme were reviewed the replacement equipment determined as needed at the time was calculated to cost £43k.
- 3.4 The final cost of removing the redundant equipment, extensive remedial ground work and site preparation along with the substantially increased safety surfacing required has increased the cost of the renewals to £51k an increase of £8k above that already approved.
- 3.5 Members will note the request for the additional £8k of funds (totalling £51k) remain within the £68k monies set aside for the approved renewals programme for 2016/17 and still result in £17k less capital expenditure than was originally assumed.

5.0 FINANCIAL AND OTHER RESOURCE IMPLICATIONS

5.1 The approved play area renewal and replacement programme had assumed £68k as the capital expenditure needed for new play equipment in 2016/17. This request to release a further £8k from the Special Expense reserve to cover the actual replacement costs can still achieved from the monies set aside for the programme and as such should have minimal implications in regards to finance or resources.
