1. Membership

The Melton Mowbray Masterplanning and Delivery Steering Group will consist of the principal developer and landowner interests, Melton Borough Council and Leicestershire County Council officer representatives, Prospect Leicestershire and other appropriate Agencies. [Name/list]

2. Structure

The structure will consist of the Masterplanning and Delivery Steering Group, chaired by Colin Wilkinson (Assistant Chief Executive - MBC)

The Masterplanning and Delivery Steering Group will co-ordinate and oversee the activities of three technical sub groups. The three technical groups will report to the Masterplanning and Delivery Steering Group [See reporting structure]

- Environment Sub-Group Chair TBC1
- Housing, Other Land Uses and Utilities Sub Group Chair David Pendle [Principal Policy Officer - MBC]
- Transport Infrastructure Chair Joanne Eynon [Team Manager (Transport Strategy)]

The technical groups will be chaired and managed by an appropriate lead officer (identified above) supported by developer consortium interest [to be identified].

Secretariat and programme management support will be provided by MBC and Prospect Leicestershire

3. Purpose

- Manage the technical development of a concept master plan and delivery plan to support the adoption of the Melton Core Strategy evidence base and subsequent DpDs/SPD.
- 2. Provide guidance to the developer consultant team(s) on preferred development options in relation to the concept master plan and supporting documents
- 3. Act collectively in managing any emerging issues and constraints in the development of the concept master plan and delivery plan
- 4. Engender a partnership approach to the management and delivery of the Melton SUE.

5. Support consultation activities with key stakeholders under the "duty to inform" as part of any DpD/SPD process and preparation and adoption by the LPA.

4. Function

- 1. Its primary purpose is to manage the interface between the development of the draft core strategy, its direction of growth, other emerging DpDs as defined by the LDS, stakeholder engagement and master planning and design principles.
- 2. Support with direction and advice related to best practice, knowledge and experience concerning the delivery of a sustainable urban extension.
- 3. Maintain a strategic overview of the concept masterplan rather than individual interests
- 4. Determine delivery priorities for response and action in the delivery of the Core Strategy DpD
- 5. Ensure appropriate control documents are in place for the programme and project management of the master plan/delivery plan and stakeholder engagement.
- 6. Offer informed advice to officers and partners relating to development/phasing and delivery of the Melton SUE
- 7. Ensure that work undertaken is consistent and complementary to other activities undertaken as part of the Melton Core Strategy and other DpDs
- 8. Maintain clear and positive relationship with Melton interests, forums and groups
- 9. Support the work of the LPA in promoting Melton SUE as a direction of growth throughout the Core Strategy submission and EiP process

5. Key Outcomes

- A composite master plan for the Melton SUE which meets the key criteria identified by technical working groups.
- Demonstrate a critical and reasoned analysis of development constraints, options appraisal, preferred form of development and its deliverability.

6. Accountability

The technical sub groups will report to the Masterplanning and Delivery Steering Group through their chairs and lead officer.

The Masterplanning and Delivery Steering Group will report to the Melton Local Development Framework Task Group through its chair and as a standing item at Task Group.
