Decision	Approval to award Crown Commercial Services framework utilities contract to EDF Energy for the supply of electricity for the corporate assets including some landlord external lighting.		
Reason for Decision	Crown Commercial Services framework is the framework supplier to the Crown Estate, and many local councils also use it, the framework provider is able to secure competitive rates for utilities through its bulk buying power. The framework administrator is required by law to competitively tender the award of its utility suppliers at least every 4 years, and EDF Energy has won the framework contract for electricity going forward from April 2020.		
Alternative options rejected	Not to sign the decision record – this is not recommended as the council requires utility contracts to discharge its functions.		

Legal implications	The Council has the power to enter into contracts in order discharge its functions (Local Government Act 1972, s111 and the Local Government (contract) Act 1997, s1).			
Financial implications	The cost of meeting corporate electricity needs for the year 2019/2020 was approximately £110,000.			
	The Budget for 2021/22 has been reviewed and taken into account the previous costs to ensure there is sufficient budget in place to meet the costs of the new contract.
