To prevent crime and disorder	yes	To quote Noisily Festival Ltd. it is 'inevitable and unavoidable' that there will be crime in the form of illegal drugs within and around their sites. This is, however avoidable, if they don't get a licence granted. There will also be disorder to the entire neighbourhood in the form of seriously excessive amounts of traffic and noise - not to mention the level of litter.
Public safety	yes	This site is in a remote, rural setting and accessed only by single carriageway roads which would make any access by emergency services extremely difficult. The access to the site is likely to be by private motor vehicles as there is very poor public transport in the area and this will be a danger to all road users, especially if drugs are involved.
To prevent public nuisance	yes	With the dramatic inevitable increase in traffic, increased noise and light levels this will severely negatively impact on the local resident population in the surrounding villages. it will also be detrimental to the wildlife in the area (which I know isn't taken into consideration in this process - but in such rural areas it definitely should be).
To protect children from harm	yes	As the suggested site covers part of The Jubilee Way (a very popular public footpath frequented by families) it's not clear what access will still be available to the public which is wrong especially as people travel from outside the area to walk this route. Children have had a very difficult time through Covid and to have restrictions put on their ability to access public paths is wrong. This area also has many, many cyclists using the lanes in the beautiful Vale of Belvoir, including families and this will be extremely dangerous with the extra traffic on the roads.
