To prevent public nuisance		<p>The proposed site for this event is approximately 1 mile from my village. Terrace Hills Farm is located on top of an escarpment overlooking Stathern and nearby villages. In their own online advertising, the event organisers proudly proclaim themselves to be 'one of the loudest and freest festivals in terms of sound'. The impact upon the residents of Stathern will be immense, with the festival's 'Quadraphonic Funktion One System' belting out 'the repetitive beat of techno' until up to 5am. It will be impossible to contain the sound (and light) disturbance from this event, making the site totally unsuitable and it's impact upon the local residents intolerable. In addition there are no main roads serving the proposed site, with no public transport. Therefore all visitors will need to drive, which will cause absolute chaos on the lanes serving the local communities. My own lane is single track for much of it's length and already becomes congested at peak times (school run/ early evening). Like many of my fellow villagers, i commute to work and am on call at weekends, so the congestion that this event would inevitably cause is of serious concern. With an attendance of up to 10,000 people, this event is totally out of scale with the proposed setting. The noise and traffic would inevitably create a public nuisance.</p>
