To prevent crime and disorder	Yes	We have a professional event horse competition yard which
		represent team Great Britain next to the proposed event.
		There could be no guarantee that there wouldn't be any danger or stress to our business and animals. This would mean that for the duration of the event we would need to move our entire hard, 13 horses to a different premise at great expense and stress during the middle of the eventing competition calendar. We would also have to return to the yard when the event is on going and have 24 hour security to protect our property from damage.
		Our hay production for our completion horses will also be jeopardised. We have a foot path on our property which runs from Stathern into the wood which will most certainly be a way of access to the festival which would not be able to be controlled effectively in the woods. We would not be able to guarantee there could be any narcotics left in said fields because of this we would not be able to feed the hay to our competition horses for years to come as our horses are dope tested at top level. See map below of hay fields used.
		Paddocks also used by our horses would not be able to be used for several years until the risk of narcotic pollution could be guaranteed.
		In short, the risk would be far too great. We either move the entire business for good or risk representing Great Britain with horses doped by others.
		With regards to noise please note. When a concert or festival is held at Belvoir Castle we can clearly hear it and that is twice as

		far away in a natural sound bowl. The noise from this festival will be unbearable.
Public safety	Yes	Public safety would be at risk for years to come as the wood is used daily by walkers etc There could be no guarantee that narcotics or broken glass would not be left in the woods for the public or wildlife to endanger themselves on.
To prevent public nuisance	Yes	The people of Stathern would not be able to sleep for fear of damage to their property for the 4 days that the festival run and this would put risk and stress on the local's health and well being.
To protect children from harm	Yes	Local children will always be at risk from such events held on public access roots. There is also a risk not from the event its self but people accessing the event drink / drug driving, This cant not be controlled.
