To prevent crime and disorder	Yes	<p>With the consumption and supply of alcohol and illegal drugs there is strong evidence that by allowing this application to go head crimes could take place in the local area.</p> <p>They have widely publicised their collaboration with the Psychedelic Society who openly support the use of psychedelic substances.</p> <p>They were unable to prevent the death of a Brighton student even with their 'drug monitoring agencies' in place.</p>
Public safety	Yes	<p>This site includes a very steep hill which is heavily wooded, which provides obvious danger for festival goers especially given points raised above.</p> <p>The site is near several areas of water in hard to reach locations for emergency services. It would be nearly impossible to fence these off.</p> <p>The site would be nearly impossible to fence off given its steep slopes and woodland. This leads to big public safety matters as people try to gain free entry via the various footpaths and other open areas. These people could include the local younger people. Access for emergency services would be by two single carriage roads and then by foot.</p> <p>The now proposed access to parking off long lane would mean that road would become a complete log iwth cars queeing as it is a small single carriage way with no ability to keep the traffic flowing again causing issues for emergency services both for the festival and the general public.</p>

To prevent public nuisance	Yes	<p>The revised plan shows the festival being less than a mile from the village of Stathern and even closer to my residence and the residence of my;</p> <p>livestock. The noise from this festival would be worsened by: The long operation hours 10am-5am! with the time of year most residence will have windows open bu the noise will make it impossible for them to rest let alone sleep.</p> <p>The application is for 10,000 people but with no public transport to the site it would mean travel by cars causing traffic issues. this traffic will no doubt back up past my farm entrance potentially slowing any vets that may need to visit. It is also harvest time meaning large farm machines will need constant access from both directions.</p>
To protect children from harm	Yes	<p>Mostly points already made above. Young people use the woodland, often with friends and family so loosing access along the jubilee way will affect them. Children and young people are most at risk from the excessive amount of traffic this event will generate. Their sleep is also likely to be affected with the light shows and music lasting till early hours. The children will still be at school so it could have a knock on effect for their school work and attendance.</p>

These woods have been home to many wild animals without any disturbance and yet its thought a good idea to bring a festival into their precious homes. The woods are also home to a vast variety of wild flowers including bluebells - what a shame for this to be trampled on and ruined.</p> <p>Why can't it be held at the already purpose site the castle own and where they hold other music events!</p> <p>In closing i do not believe this application should be granted. The size, volume and impact on the local community and wildlife should be a priority this festival will be a danger for the local children and a thret to public safety in general.</p>
