Changes to how we prioritise homeless applicants

In order to comply with the Homelessness Reduction Act and guidance relating to homelessness applicants, we are proposing to place applicants who we assess as homeless and in priority need of housing in Band 1 of the housing register (the highest priority), to seek to accommodate them as soon as possible.

We are also proposing to directly match those applicants to properties (based on the number of bedrooms required as opposed to the property type. For example, if someone required a 2 bedroom property, they could be match to 2 bedroom flats, maisonettes, houses or bungalows). This is in recognition of their urgent housing requirements.

4. Part 2

Options to ensure the housing register can better meet local housing demand

The process of developing a new allocations policy provides us with the ideal opportunity to better match the number of applicants on the waiting list with the annual number of properties which become available to let.

The purpose of this is three-fold:

- 1. To ensure that eligible applicants have a realistic prospect of being housed
- 2. Not to raise peoples' expectations unrealistically
- 3. By reducing the overall number of applicants on the list, we are able to offer a more bespoke and supportive service to enable people to access suitable accommodation.

To achieve this, the Draft CBL and Housing Allocations Policy includes looking at residency and employment. This will both reduce the total number on the waiting list to a more balanced figure, and also focus the allocation of much needed social housing on those applicants with the strongest connection to the borough, though there are exceptions to the local connection criteria, for example, for people who work in the borough or who are fleeing violence or harassment.

The proposals also look to remove those Band 4 applicants with no housing or welfare need, unless they are eligible for older persons accommodation.

Please note:

For those current applicants who are no longer eligible to remain on the council's housing register, advice and support will be provided to assist them in finding alternative accommodation.

The following three questions will look at the new proposals to reduce the number of applicants on the register, as stated above.

Changes to the local connection criteria for both residency and employment

Residency

The new policy will move from the current definition for residency, which is living in the borough for "6 out of the last 12 months or 3 out of the last 5 years" to state that applicant will need "2 years residency within the borough" and it will remove "moving into the borough due to a family connections" as a classifying factor, unless to give or receive care/support.

The removal of Band 4.

Band 4 currently includes applicants with no housing need, for example:

- Private tenants and tied tenants adequately housed with no medical or welfare or exceptional need to move
- A new applicant with security of tenure and no welfare or medical need
- A transfer applicant who requires a move to the same bedroom size property and has no medical or welfare or exceptional need to move.

The proposal is to remove applicants without a housing need. However, we will move those people currently in Band 4 who are eligible for older person's accommodation, to Band 3. This is because we have a larger supply of older person's accommodation for which there is less demand.
