**Please state the ground(s) for review** (please read guidance note 2) Environmental Healh is bringing this review in the interests of preventing a public nuisance.

That in 2022, the Designated Premises Supervisor (DPS) - Simon Brooks, breached the following premises licence conditions, and in doing so has:

- Failed to provide compliance data requested by the regulator
- Caused a public nuisance resulting in residential disamenity
- Created a 'no confidence in management' situation

'The Premises Licence Holder, DPS or nominated person shall ensure that music and speech from regulated entertainment does not exceed the 'background' noise level at the boundary of the nearest noise sensitive property at any time. For the purpose of this condition, noise from music and speech would not exceed the background noise level when it does not alter the perception of the ambient environmental noise that would prevail in the absense of the source in question.'

'Where regulated entertainment is to take place outside after 23:00, the Premises Licence Holder, DPS or nominated person shall undertake an observation of the noise environment at the nearest noise sensitive property to ensure compliance with condition (above). The observation shall be documented and retained for 12 calendar months and made available to the Licensing Authority or Responsible Authorities upon request.'

Note:

An objective level of 'background' or below was selected because if the volume of music in the external environment does not exceed the background sound level, it will be inaudible in the internal environment due to to the protections afforded by the building fabric. This is consistent with guidance document Good Practice Guide on the Control of Noise from Pubs and Clubs 2003 issued by the Institute of Acoustics.

An observation of regulated entertainment is required for events after 23:00 due to the risk of sleep disturbance. 'Night-time' hours are recognised as 23:00 to 07:00; during this time residents have a greater expectation of residential amenity.

Failure to provide compliance data -

Environmental Health requested Simon Brooks (via George Domleo of Flint Bishop) submit his monitoring records on 22 April 2022, 5 May 2022, 14 July 2022 and 10 August 2022. At no time has Simon Brooks submitted the requested information.

In the absense of the requested information, Simon Brooks as DPS has failed to demonstrate compliance with the above conditions, namely:

noise from music and speech shall not exceed the background noise level at any time.the observation shall be made available to the Responsible Authorities upon request.

Cause a public nuisance -

Environmental Health received a complaint from local resident - Kaisey Lambert on 17 April 2022 concerning nuisance noise from amplified music and speach from The White Lion. A further complaint was received on 9 July 2022.

Kaisey Lambert reported experiencing instrusive music and speach until midnight and occasionally after midnight during the 2022 summer entertainment season. The volume of the music and speech resulted in a loss of residential amenity. It impaired Kaisey Lamert's 'enjoyment' of her property, prevented her from sleeping and required her to take unreasonable steps to mitigate the noise eg. staying-up later than desired, closing windows and turning up the television.

It can be seen that the volume of music and speech experienced by Kaisey Lambert is inconsistent with the acoustic objective level of 'background' or below. For Kaisey Lambert to be so affected, noise from The White Lion must have exceeded external background levels.

No confidence in management -

Environmental Health notified Simon Brooks of the two resident complaints and requested that he submit his monitoring records on four occasions. Environmental Health did not receive a response from Simon Brooks until 11 August 2022. A period of nearly 4 month from our initial resident complaint and subsequent contact with Simon Brooks (via George Domleo of Flint Bishop) on the 22 April 2022.

Simon Brooks claimed not to know what information was required. We submit to the subcommittee that The White Lion premises licence, conditional requirements are abundantly clear. Simon Brooks was instrumental in the major variation of The White Lion premises licence in August 2020 which brought about the new conditional requirements. Moreover, Environmental Health explained what information should be recorded whilst making observations to Simon Brooks in March 2022 during at subsequent major variation. If Simon Brooks did not understand the conditional requirements or the nature of the compliance data requested, he had every opportunity to seek clarification prior to August 2022.

Simon Brooks claimed not to have been at The White Lion bar weekends, thus inplying that he wasn't resident to either (a) manage regulated entertinment or (b) respond to the Regulator. We submit to the sub-committee that the premise licence identifies Simon Brooks as the DPS and the person responsible for the day-to-day running of The White Lion. He is responsible for ensuring compliance with all conditions on the premises licence. Depite this claim, Environmental Health has obtained evidence to demonstrate that Simon Brooks was in fact managing regulated entertainment at The White Lion during the Summer of 2022.

It is the opinion of Environmental Health that Simon Brooks was managing regulated entertainment at The White Lion during the Summer of 2022, he did understand what compliance information was required of him but purposefully ignored the Regulator. Simon Brooks made this decision because he did not want to be bound by the premises licence conditions and to run down the clock for enforcement action for the 2022 Summer entertainment season.

Consequently, Environmental Health has no confidence in Simon Brook as DPS of The White Lion.
