My name is acoustic based easy listening which can evolve into folk rock when the need arises. Essentially, the music I play is covers by the likes of Paul Simon, Beatles, Cat Stevens, Seth Lakeman, Gerry Rafferty, and when the need arises to more up-tempo songs by the likes of Stereophonics, Waterboys, Levellers, Bryan Adams etc. I also play my own originals. I have spent many years honing my craft, buying instruments (six and twelve stringed guitars), amplifiers and microphones.

To put a ban on live music at pubs such as the White Lion at Melton Mowbray would affect me in the same way as it would any full band with drums and electric guitars and yet, the music I play is very different. I have played live music in many pubs and this is the only way I can get my own material heard. My music brings pleasure to people wherever I go and to place a live music ban would deny these people and myself the pleasure that comes with live music.

I would hope that any person who buys a house in close proximity to a pub, a school, a factory, a farm, a football ground etc. would understand that there are compromises that come with buying in close proximity to these places. Any complaints about the impacts of such proximities should be met with a level of sympathy but not a decision that ruins the enjoyment of the many in favour of the short-sighted few.

I sincerely hope you will allow live music to thrive as it has done for so many years. The UK has a long established tradition as world leaders of great music. This is can only continue if musicians have a place to play, and an audience to perform to.

I would finally point out the effect on the UK economy. Musicians need instruments and PA equipment, all bought from shops, all of whom pay tax. Musicians like me are income tax registered, and we pay tax on our earnings. Musicians like me, go to hear other musicians play and we pay to do so. Any decisions that curtail these activities will have a negative impact on the hospitality trade and the entertainment industry alike.
