PL40	<p>Application 22/00028/COU Field OS5576, Gaddesby Lane, Barsby (Change of use of existing farm building into cattle building, retention of existing earth bund and re-submission of alterations to existing vehicular access)</p> <p>The Planning Officer (SM) addressed the Committee and provided a summary of the application.
