

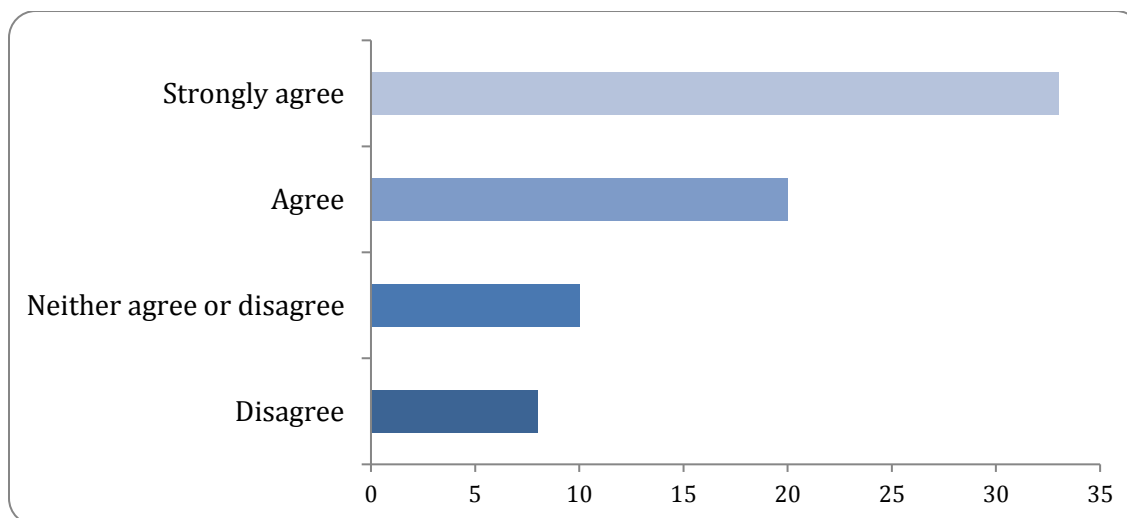
Vision 2036 consultation

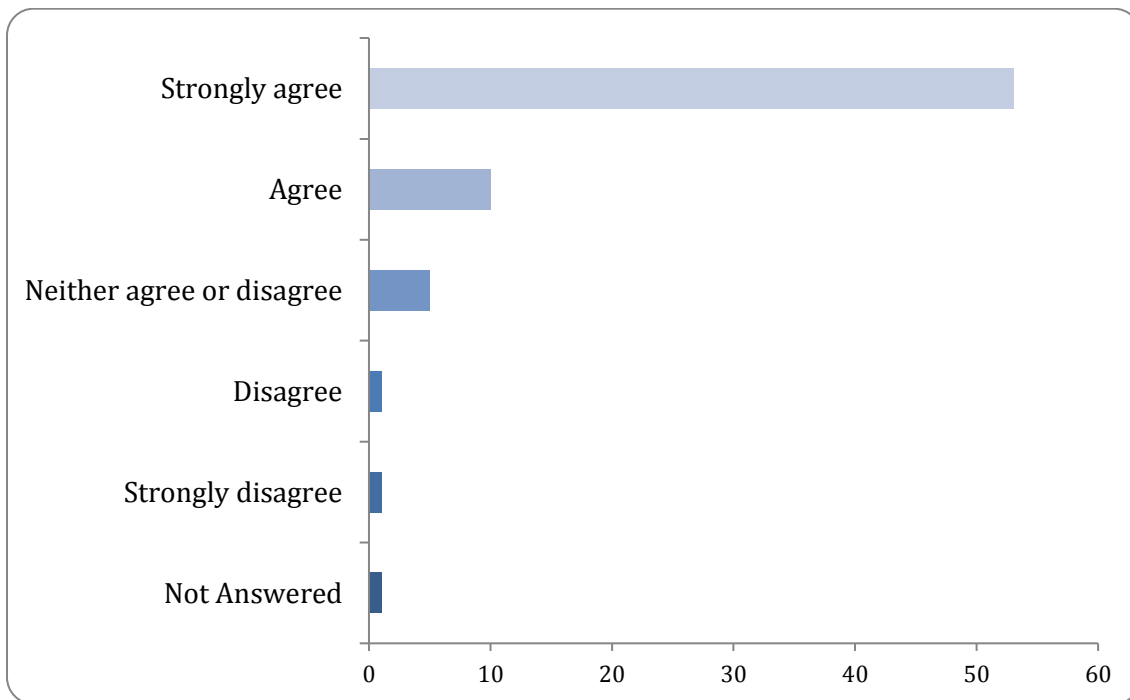
Comments left

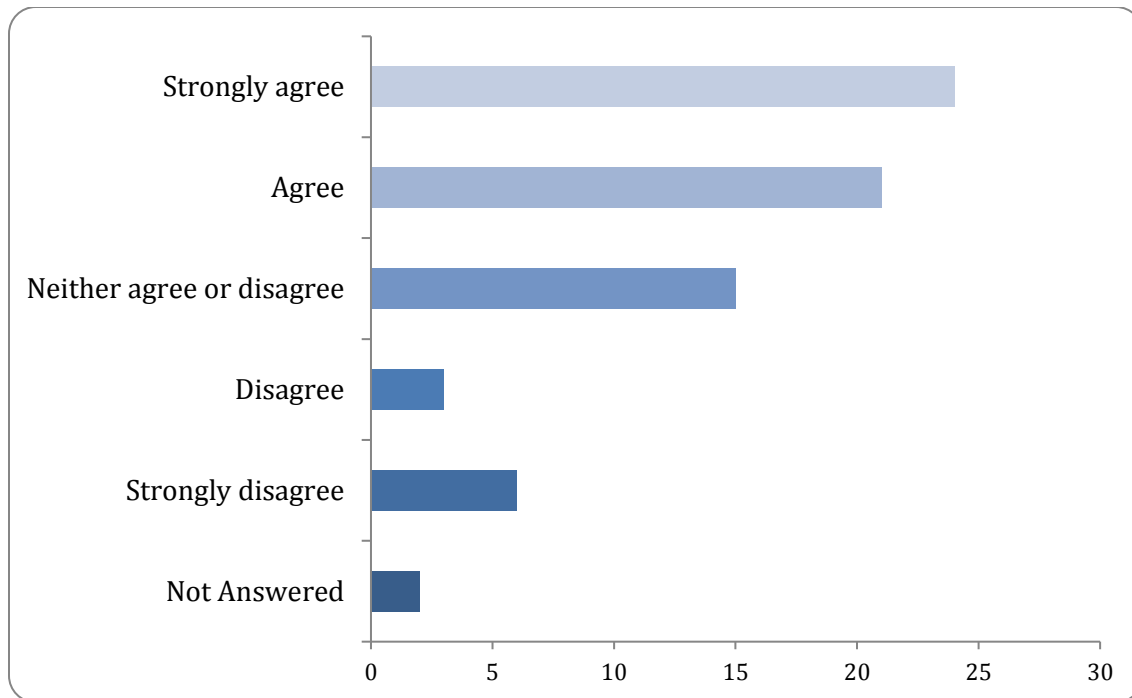
Comments left

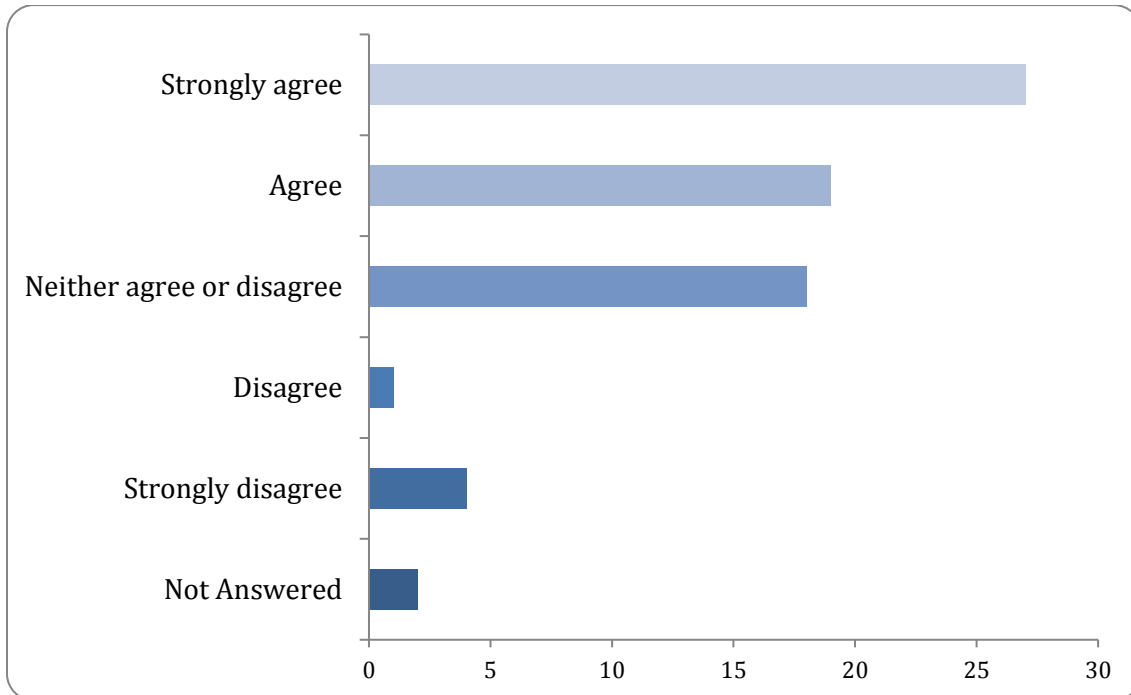
- **A direct transport link with Nottingham is definitely mandatory, be it a direct train or a direct bus to link up the huge gap.**

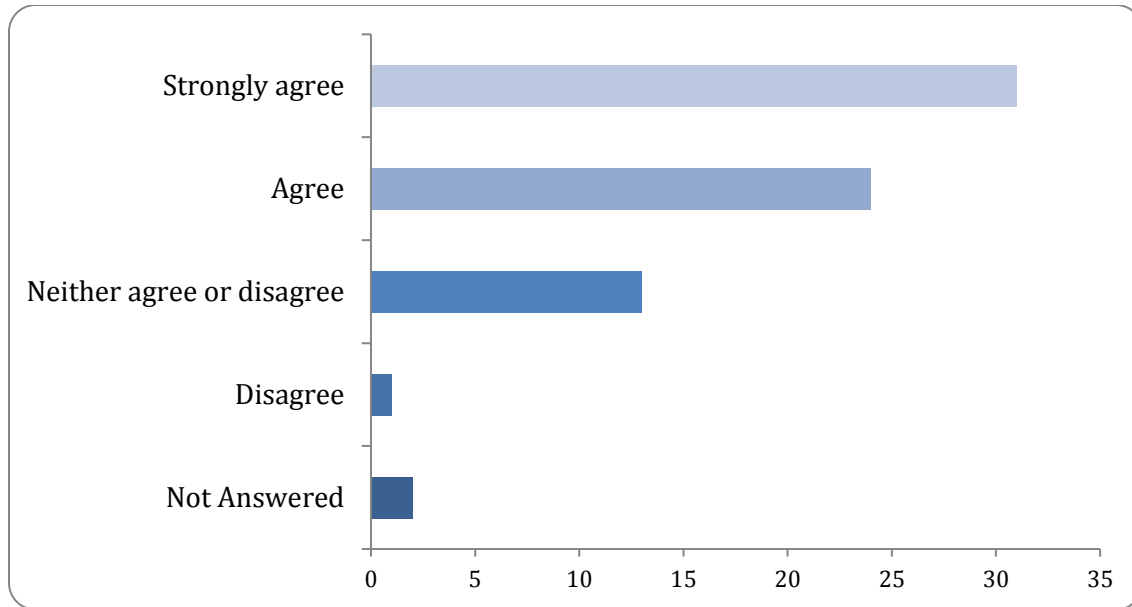
Comments left

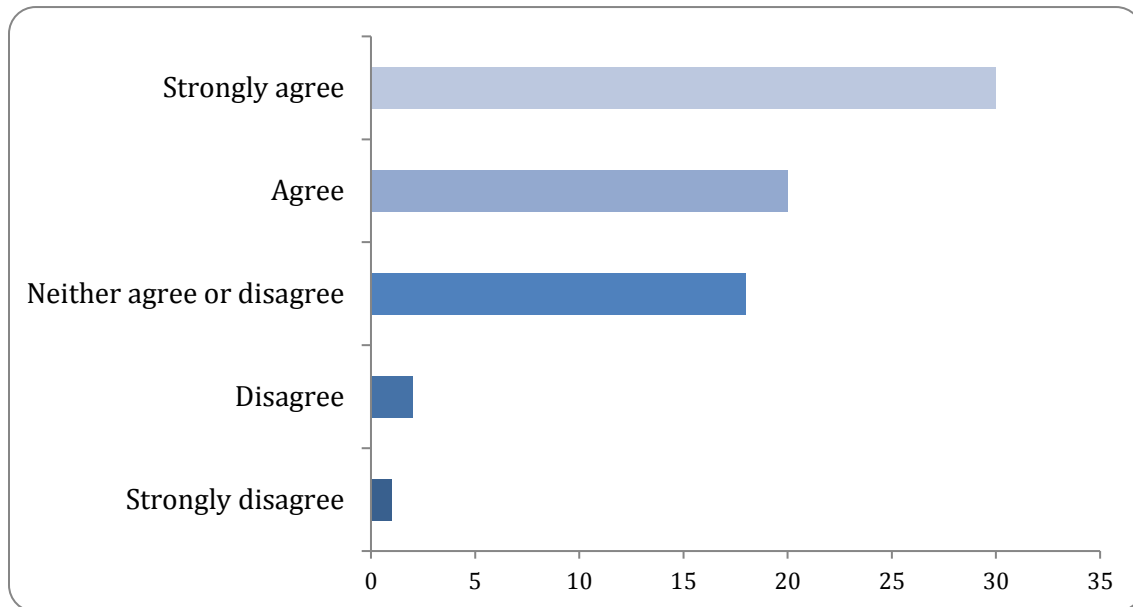

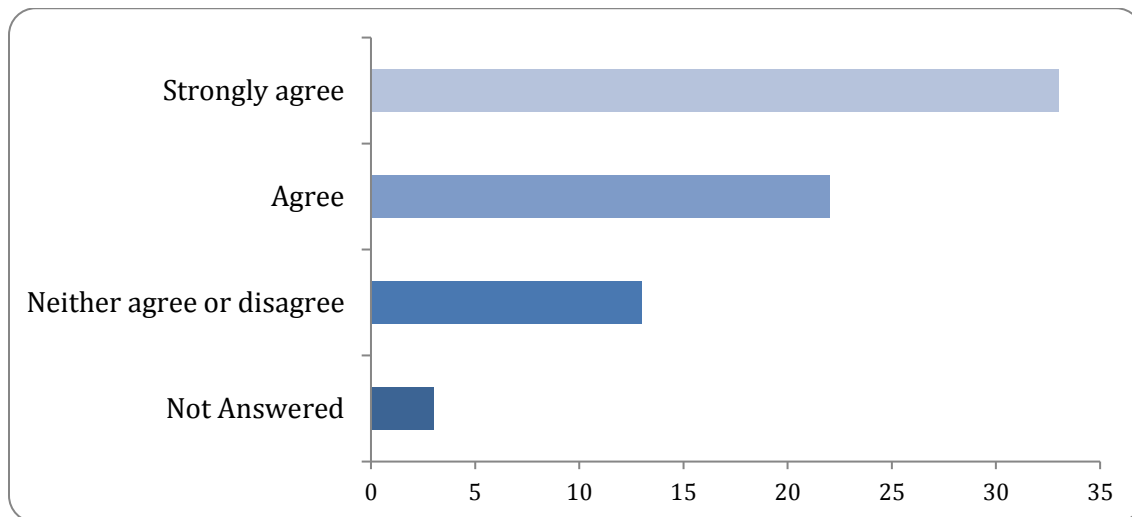
Comments left

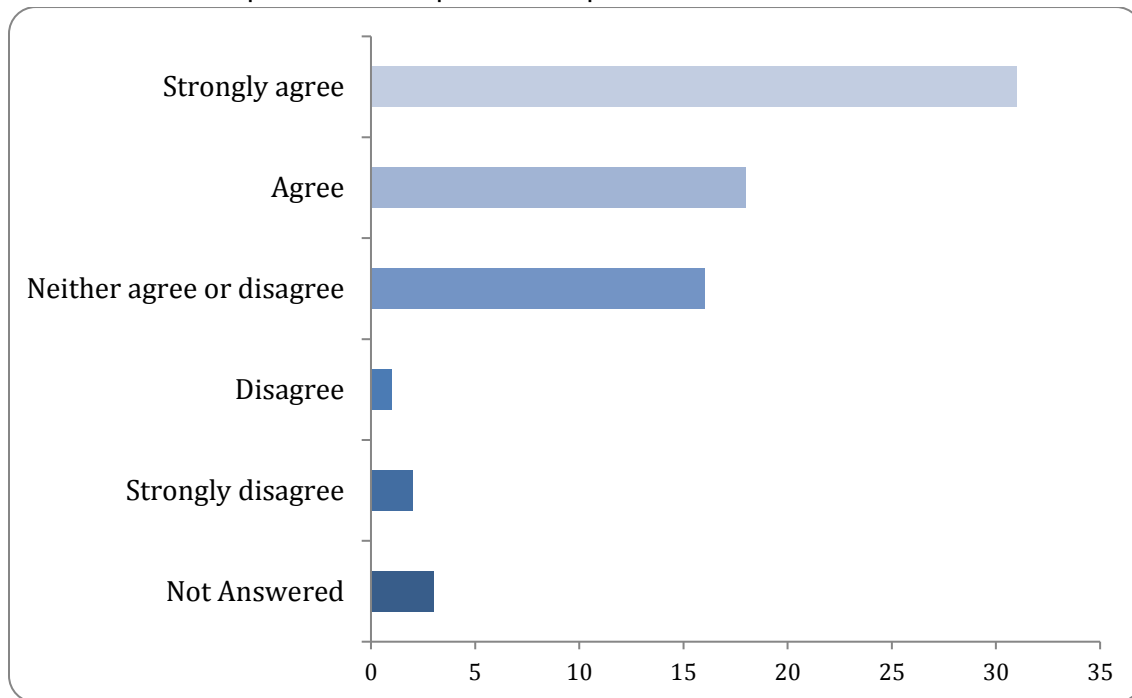
