Public Safety:

Traffic Mgt - Mud on Road, incomplete/inappropriate signage and poor attention to dynamic traffic management - breach of conditions as outlined on Pg 8 of the MMA0324

Failing to Prevent Public Nuisance: Noise - breach of conditions as outlined in Pg 10 of the MMA0324 .

Public Safety - Traffic Mgt - Mud on Road - breach of conditions as outlined on Pg 8 of the MMA0324

Festival goers, local residents and visitors through the Vale were put at significant risk by the lack of appropriate traffic Management

The organisers purported to provide a road cleaner due to the mud on the road, but this was quoted as being a response to the unexpected mud on the road and was not therefore available throughout the problem period. The organisers were fully aware this was grassed farm land and had a weather forecast available to them. This should have been provided from the outset of the weekend. Furthermore the signage advising motorists of the mud on the road was literally just as the mud started. Any vehicle would be already on the mud as it slowed down. Despite repeated emails to Highways, the road remained a risk to the public with grossly insufficient and inadequate signage and mud on the road. See attached images.

The organisers themselves commented that the speed vehicles travelled past the site ingress/egress was a concern. This is in a section of Long lane that has already been reduced by Leicestershire County Council and Leicestershire Police to a 50mph limit in recent years due to the high accident risk. Festival goers were walking along this section of Long Lane having been dropped off in local villages.

The signage provided was grossly inadequate. The majority of it was Correx which manufacturers describe as "Correx is a fluted plastic board which is made from corrugated polypropylene. It's rigid, colourfast, waterproof and weatherproof, which makes it perfect for outdoor advertising and signage. Correx is also incredibly lightweight and around 3mm thick". The attached images clearly show Correx signs attached with silver tape to thin posts. These were blown over by the large vehicles travelling along Long Lane repeatedly. Even those attached to the weighted bases were also blown over, again this can be clearly seen in the images attached.

The speed on this section of road, the totally inadequate signage and the mud on the road made this a serious risk to the public travelling along the road and to those accessing the site.

Failing to Prevent Public Nuisance:

Noise - breach of conditions as outlined in Pg 10 of the MMA0324

This was the primary concern of local residents due to the location and the type of music offered. Despite the very stormy weekend, which reduced the festival 'live' periods by almost 50% (lightening and torrential rainfall closed stages and music early), the organisers failed to keep within the promised noise parameters outlined in the Conditions. This is a clear and evidenced breach of conditions and caused the most distress and nuisance to local people.

This festival has a track record of attracting noise complaints.

Complaints were made to the previous Licensing Authority in 2012. 2014, 2016, 2017 (the festival then didn't run for 3 years due to Covid)

Noise monitoring was not consistent with the Conditions, 8 monitoring locations were provided to the Licensing Authority, yet only 6 sets of data provided by the organiser. (see attached detail) Even with this limited data, the organisers are still evidencing that they cannot meet their existing conditions and are following a similar pattern to that in their previous locations.

This breach constitutes a public nuisance and the evidence is clear that this will only increase in severity with normal weather conditions when the festival operates the full 4 days and with the approved level of participants

Failing to prevent Crime & Disorder

Death of worker on site - breach of conditions outlined under Prevention Of Crime & Disorder - Page 8 of the MMA0324

Noisily presented a zero tolerance to drugs in their representations the Licensing Authority, local people and the SAG. The death of an individual engaged for services in site, as a result of illegal substances taken at the event, clearly evidences that not only have they have failed to keep the public safe , and have not taken a zero tolerance approach as promised.

## Failing to protect Children From Harm:

The failure to provide a full perimeter fence allowed anyone, including children unmonitored access of the site. It was impossible to provide adequate security as proposed in the Conditions MMA0324 Pg 9 as there were vast 'open access' entrances that were not secured.

The breach of noise conditions and the increased risk to public safety and public nuisance along with a failure to protect children from harm evidenced above, requires this Licence to be Reviewed.
