REPORT OF HEAD OF COMMUNITIES & NEIGHBOURHOODS

MELTON LOTTERY- GOOD CAUSES – AMENDMENT TO GRANTS TO ORGANISATIONS

1.0 **PURPOSE OF REPORT**

1.1 For Members to approve an amendment to the current grants to organisations, requiring them to register to the Melton Lottery before consideration is made on any award of Grant.

2.0 **RECOMMENDATIONS**

- 2.1 It is recommended that the Members:
 - (i) Members approve amendments to the Grant to Voluntary Organisations and Community Facilities Grants application forms to ensure that any organisations applying for grants are signed up the lottery- good causes and proactively promote the lottery for their Organisation.

3.0 KEY ISSUES

- 3.1 The Council awards annual grants to voluntary and community organisations and also determines applications from originations as part of the Community Facilities Grants scheme.
- 3.2 While the grants enable organisations to deliver valued and beneficial services often to vulnerable people we need to be mindful of the on-going pressures on local government funding.
- 3.3 The Melton Lottery was established to help good causes raise monies for their organisation and mitigate the reliance on the council to continue funding them.
- 3.4 To incentivise the Melton Lottery further it is proposed to make it a condition that any organisation seeking financial support from the Council needs to register for the Melton lottery and to pro-actively promote the Lottery for their organisation
- 3.5 Overtime this approach will allow the council to review its allocation of grants and enable organisations to be more self-sustainable, instead of relying on grants from the Council, which will become more difficulty to sustain.

4.0 POLICY AND CORPORATE IMPLICATIONS

- 4.1 There are clear links to some of the priorities in the Corporate Plan specifically:
 - o Promoting a vibrant and sustainable economy, focused on growth and prosperity
 - o A more Agile Council.

5.0 FINANCIAL AND OTHER RESOURCE IMPLICATIONS

5.1 The Council currently allocated £71,710 in the 2017/18 budget for annual grants to a variety of organisations i.e. CAB, Clockwise, Furniture project, Shop Mobility, Age UK. These could reduce when these organisations start to generate further income from the Lottery.
