Reason for Decision	Following a referendum where more than 50% of those voting vote in favour of the proposal, the planning authority must decide to "make" the Neighbourhood Plan part of the Development Plan (Section 38A (4)(a) of the Planning and Compulsory Purchase Act 2004) and the Neighbourhood Planning (General) Regulations 2012 (as amended).		
Alternative options rejected	There is no alternative, following a successful referendum the authority must make the neighbourhood plan and it will become part of the statutory development plan, unless it is considered that the making of the plan would breach, or would otherwise be incompatible with, any EU obligation or any of the Convention rights (within the meaning of the Human Rights Act 1998) (Section 38(A), paragraph 6 of the Planning and Compulsory Purchase Act 2004). The Council do not consider this to be the case and consequently, making the Neighbourhood Plan is the only		

	reasonable alternative.
